ORDINANCE NO. 88-2

AN ORDINANCE PROHIBITING COMMERCIAL TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF HEBRON ESTATES, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED by the City Commission of the City of Hebron Estates, Bullitt County, Kentucky, as follows:

Section I: The City of Hebron Estates, Bullitt County, Kentucky, does hereby prohibit ingress and egress by the use of the public right of ways located within the corporate boundaries of the City of all commercial vehicles except those vehicles used necessarily for delivery or removal purposes within the City limits. There is prohibited any and all commercial through traffic and parking within the corporate limits of the City of Hebron Estates.

Section II: The City Commission hereby directs the Mayor to post at the entrance of each right of way adjacent to the corporate boundaries of the City a traffic sign stating the City's intentions to prohibit commercial traffic from ingress and egress into the corporate limits of the City.

Section III: There shall be no overnight parking of motor vehicles on the streets in the City of Hebron Estates except, when due to inclement weather, the driveway or passway to any residence is impassable.

- (A) "Overnight parking" as used in Section III herein shall mean continuously from 8:00 p.m. until 6:00 a.m. the following day.
- (B) "Motor Vehicle" as used in Section III herein shall mean every device in, upon or by which any person or property is or may be transported or drawn except devices propelled by muscular power.

Section IV: No motor vehicle with a gross vehicle weight in excess of 11,000 pounds shall be parked anywhere within the City except for loading or unloading and then not for more than a period of eight (8) hours.

- (A) "Gross vehicle weight" as used in Section IV herein shall mean the manufacturer's gross vehicle weight of the motor vehicle.
- (B) "Motor vehicle" as used in Section IV herein shall mean every device in, upon or by which any person or property is or may be transported or drawn except devices propelled by muscular power.
- (C) Section IV of this Ordinance shall not apply to any recreational motor vehicle which contains sleeping and cooking facilities.

Section V: Violation of Sections III or IV hereof shall be punishable by a fine of not less than Ten Dollars (\$10.00) nor more than One Hundred Dollars (\$100.00).

Section VI: This Ordinance shall take effect upon publication.

Section VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not effect the remainder of this Ordinance.

Section VIII: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.
