## ORDINANCE NO. 2018-01

AN ORDINANCE CLOSING/ABANDONING A PORTION OF OLD HEBRON LANE AS A PUBLIC WAY MAINTAINED BY THE CITY OF HEBRON ESTATES.

WHEREAS, the City of Hebron Estates thru annexation may have become responsible to maintain a portion of a public way known as Old Hebron Lane, and

WHEREAS, a portion of this public way is no longer needed as a portion of the municipal roadway system requiring it to be municipally maintained, and

WHEREAS, KRS 82.405 specifies the procedure which must be complied with to legally close/abandon this portion of Old Hebron Lane, now, therefore,

The City Council of the City of Hebron Estates, Bullitt County, Kentucky, does hereby ordain as follows:

## SECTION ONE: LEGISLATIVE FINDINGS OF FACT.

- a) The property owners in or abutting this portion of Old Hebron Lane, are:

- b) Written notice was given to each of the owners of record, in or abutting the portion of Old Hebron Lane to be close/abandoned by mail on January 9, 2018.
- c) All property owners in or abutting the portion of Old Hebron Lane to be closed/abandoned have given written notarized consent to this closure/abandonment.

## **SECTION TWO:** Description.

The portion of Old Hebron Lane to be closed/abandoned by the City of Hebron Estates is described as follows:

Beginning at an iron pin w/cap #3018 in the northeast corner of Cowan as depicted on Boundary Survey recorded in Deed Book 934 Page 49, thence with the east property line of Cowan S 37° 44' 18" W 128.91' to an iron pin w/cap #3018, thence S 05° 58' 22" W 41.50' to an iron pin w/cap #3018 in the northwest corner of Lot 12, Horse Run Estates Section 2 (Plat Cabinet 2 Side 73), thence with the north property line of Horse Run Estates Section 2 (Plat Cabinet 2 Slide 73) N 87° 21' 39" E 343' to a point, thence N 60° 18' 46" W 46.14' to a pk nail in the northeast corner of Pierce as shown on survey recorded in Deed Book 238 Page 532-A, thence S 88° 38' 03" W 250' to an iron pin, thence N 35° 51' 50" E 105.67' to a point, thence S 51° 30' 42" E 40.00' to the point of beginning.

<u>SECTION THREE:</u> This Ordinance shall be published according to law and a certified copy shall be filed with the office of the Bullitt County Court Clerk.

SECTION FOUR: This Ordinance is enacted pursuant to KRS 82.405 et seq.

<u>SECTION FIVE</u>: Any ordinances or part of ordinances in conflict with this Ordinance or any part of this Ordinance are hereby repealed.

<u>SECTION SIX:</u> Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.
