## **ORDINANCE NO. 2018-05**

AN ORDINANCE PROVIDING FOR THE PARKING OF MOTOR VEHICLES WITHIN THE CITY LIMITS OF THE CITY OF HEBRON ESTATES, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEBRON ESTATES, BULLITT COUNTY, KENTUCKY, as follows:

<u>SECTION ONE:</u> <u>No Parking Places</u>: At any time, it shall be a violation of this Ordinance to permit any vehicle to stand in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the directions of a policeman or traffic control device:

- a) In any intersection.
- b) In a crosswalk.
- c) Within thirty (30) feet of a traffic signal, beacon, or sign on the approaching side.
- d) Within twenty (20) feet of any intersection or crosswalk.
- e) At any place where the standing of a vehicle will reduce the usable width of the roadway for moving traffic to less than fifteen (15) feet.
- f) Within ten (10) feet of a fire hydrant.
- g) At any place where the vehicle would block the use of a driveway.
- h) At any place where official signs prohibit parking.
- i) At any place where the standing of a vehicle is within fifty (50) feet of the crest of a hill or rise where the vehicle is not visible to oncoming traffic; without placing orange traffic control cones at least fifty (50) feet to the rear and front of the standing vehicle. These orange traffic control cones shall be placed in the traveled portion of the roadway in which the standing vehicle is located.

## SECTION TWO: Limited Parking Permitted ONLY:

- a) Unforeseen family emergency/crisis; however, reasonable notice based on the emergency shall be provided to the Pioneer Village Police Department.
- b) The Pioneer Village Police Department may upon reasonable notice permit exception as requested by resident. The exception shall not exceed two (2) requests per year.

<u>SECTION THREE</u>: The Mayor and City Council shall cause signs to be posted in all areas where parking is limited or prohibited.

<u>SECTION FOUR</u>: There shall be no standing or parking of any motor vehicle on any public roadway (street) between dusk and dawn within the municipal boundaries of the City of Hebron Estates.

<u>SECTION FIVE</u>: No parking upon any street shall be permitted when the national weather service has predicted snow and/or ice within the area of the City of Hebron Estates.

SECTION SIX: Any person who violates the provisions of this Ordinance shall be subject to a civil penalty as follows:

- a) 1st offense written warning;
- b) 2nd offense is a \$50.00 civil penalty;
- c) 3rd offense is a \$100.00 civil penalty and the vehicle will be removed at owner's expense.

SECTION SEVEN: This Ordinance shall take effect upon publication.

<u>SECTION EIGHT:</u> Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

<u>SECTION NINE:</u> Any ordinances or parts of ordinances in conflict with this Ordinance or any part of this Ordinance are hereby repealed.
